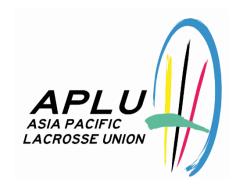
5. Presentation of President's Report

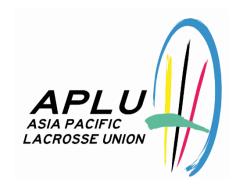

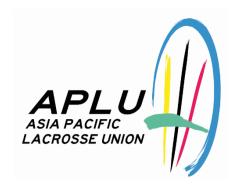
9.1 Alignment of new membership process
